- 1. The meeting was called to order at 6:30 PM with Quorum Established.
- 2. Guest speakers: Jason Berry and Kathy Johnson were present to discuss the soon-starting recreation study, along with the creation of a Parks and Recreation Strategic Plan.
- 2. Public Comment Steven Statzer spoke about a conversation with the Boy Scouts regarding continuous campfire.
- 3. Washington County Park Authority Manager Report
  - Scouts are coming for Klondike Derby this saturday.
  - Drawings, Most recent period had zero entries for site 66. Steven Statzer made a motion to amend the rules to allow the following: in the event of a site not having any entrants in a drawing, the Park Manager may offer the alternate winner of a similar site the option to accept the site that did not have an entrant. A second was made by Lisa Wilson, and the motion passed 6-0-0.
  - The staff are working on upkeep of equipment for the year.
  - Alongside equipment upkeep, staff are also working on drainage at the ballpark, which seems to be working better this year.
  - Jason started at the park earlier this month, training is moving forward well.
